ABOUT THE UNIVERSITY

University of Travnik is the first private university established with the support of the Ministry of Education, Science, Culture and Sports of the Srednjobosanski Canton, on the basis of legislation, civilizational achievements and practices the modern world today. Its primary goal is to be a generator of development and prosperity of the Srednjobosanski Canton, but also of the wider area, through rising quality of higher education - both in the central Bosnian region, and across the country.

Through the will of the founders, who, investing their own private capital in material and intellectual values, had the courage to decide to establish private Faculties, a new direction was opened and the outlook of the society on the private founding institutions of higher learning has been changed.

The University is an institution of higher education that has its legal subjectivity. It was first registered in 2007, and has, since carried out its activities in accordance with the Decision of the Ministry of Education, Science, Culture and Sport of the Srednjebosanski Canton, No.: 03-38-63/07 of 04th of July, 2007.

STATUS OF THE FACULTY

On the 29th of December, 2009 the Faculty of Law was listed in the Register of the University of Travnik in accordance with the decision of the Ministry of Education, Science, Culture and Sport of the Srednjebosanski Canton. The same Ministry on the 29th of June, 2007 had issued a Permission to begin operations and on that day the Faculty was listed in the Register of Institutions of Higher Education of the Srednjebosanski Canton. After a review by the Ministry in March of 2007 the Faculty was allowed to initiate classes for the next academic year

PAS.

Since the academic year 2008/09 the Faculty of Law enrolls students at the II cycle of studies (Master studies).

On the 20th of September, 2010 the University completed the integration process, thus becoming one of the few institutions of higher education which conforms to the legal provisions laid down in the framework Law on higher education in B&H.

Since the academic year 2011/12 the Faculty of Law enrolls students at the III cycle of studies (Doctoral studies).

University of Travnik has, on the11th of May, 2009, received interim Accreditation (no: 03-38-24/09) which was registered at the Register of temporary accredited higher education institutions in B&H. This accreditation is valid until the successful completion of the accreditation process for the University, in accordance with the criteria and procedures of the Agency for Development of Higher Education and Quality Assurance of B&H, which, together with relevant ministries supervise and inspect the validity of the operations of the Faculty of Law, which in turn forms the basis for and the guarantee of the universal validity and acceptability of the degrees granted by the Faculty of Law of the University of Travnik .

EDUCATIONAL ACCOMODATION AND TECHNICAL CONDITIONS

The Faculty of Law of University of Travnik has constant developmental tendencies and strives to perfect itself in all manner possible, and in so doing to allow students to have the most modern educational conditions at the new fully equipped facilities. The Faculty of Law has a new building with over 5.500 square meters of usable space. It is situated near Kiseljak and some 20 kilometers from the center of the capital city of Bosnia and Herzegovina, Sarajevo. It lies at the border of the Sarajevo and Srednjebosanski Canton. Thus, the Faculty of Law has large amphitheaters, large and small study and lecture halls for classes, exercises, seminars, it has luxuriously equipped offices, a library with a reading hall and an informatics center, a cafeteria and other various accommodations, all of which ensures day long stay at the Faculty. In its efforts to provide even better conditions for its students, the whole of the Faculty is covered with a wireless internet connection. In the spring, the students will have an opportunity to learn in an amphitheater in the open, after which they will be able to take a walk in a stretch of manicured woods, owned by the Faculty.

LIBRARY AND INFORMATICS CENTER

The Faculty of Law of the University of Travnik offers its students a modern, well equipped library with about 7,000 bibliographic reference units. Students have access to the highest quality electronic services, as well as two databases with over 100,000 individual sources. The Library also contains an Informatics Center. The Faculty of Law, as part of the University of Travnik is a noted publisher of university textbooks in the area of legal theory and practice, all of which greatly contributes to the development of higher education in B&H. The curricula of all subjects include textbooks from the top European and American universities, as well as textbooks written by noted professors from the Faculty of Law of the University of Travnik and other Faculties in B&H. University of Travnik publishes a journal titled "University Chronicle," in which the faculty, students and associates have the opportunity to introduce the general public to their scientific work.

COOPERATION WITH OTHER INSTITUTIONS

University of Travnik has signed a series of agreements on a bilateral and multilateral basis establishing cooperation with universities in the region, the European Union and the United States. The Faculty of Law has cooperation agreements with various government and non-government institutions and organizations. Students, during the duration of their study, regularly visit the courts, ministries and self-governing bodies, as well as other relevant institutions such as the Penal/Correctional institution in the City of Zenica (the Faculty of Law is the only institution that has had this kind of cooperation with this institution), the Institute for Intellectual Property of Bosnia and Herzegovina , etc. The Faculty of Law is also frequently visited by famous personalities from the various fields of Law and other social sciences. Statesmen, politicians, scholars, and secular and religious personalities have held and consistently hold lectures and seminars at the Faculty.

During each academic year the Faculty of Law holds several scientific conferences and research seminars on a variety of topics. In addition the Faculty of Law engages in extensive scientific research activities and is often the scene of book promotions by professors from itself, other universities in the country and abroad.

The Faculty of Law runs the Innovation Center for Curriculum Reform for Special Forms of Education and the Development of Corporate Entrepreneurship (ICE), which works to develop new and innovative methods to improve the educational process, and in its operations brings together regional and global experts alike.
